## Course Objectives

1. Attendees will develop a better understanding of options related to the care and referral of concussion patients with persistent symptoms.
2. Attendees will gain knowledge about the use of the King-Devick Test as an assessment test in concussion management.
3. Attendees will be able to apply movement screens necessary for the implementation of appropriate injury prevention strategies.
4. Attendees will identify the components of the decision making process for activating spinal motion restriction of the spine injured athlete.
5. Attendees will demonstrate the evidenced-based practices for the selection of the different types of extrication equipment and transfers.
6. Attendees will explain how to conduct the processes needed for correct placement of the spine injure athlete on the spine board.
